

# COOPERATION AGREEMENT

between

(Nashik, Maharashtra, Republic of India)

Belarusian National Technical University (Minsk, Republic of Belarus) on behalf of the Rector Sergei V. Kharytonchyk, on the one hand, and Sandip Foundation's, Sandip Institute of Engineering & Management (Nashik, Maharashtra, Republic of India) on behalf of the Director, International Affairs Cell, Dr. Dipak P Patil, on the other hand, as well as Director at World 1 Solutions Manish Vig, herein after, referred to as the Parties, confirming their interest in the development of cooperation in the field of research and teaching, to their mutual advantage have agreed as follows:

## Article 1

1. Guided by the common objectives of our higher educational institutions, the Parties declare their readiness to maintain, deepen and develop cooperation, based upon the principles of respect for each other's independence and of mutual benefit, in all fields of academic and research activity represented at their institutions.

2. Within the framework of the present Agreement, the Parties can conclude separate agreements covering all areas of cooperation specified in this Agreement.

3. For the cooperation under this Agreement, the working language is English.

4. For administrative supervision and facilitation of the Agreement, Mr. Manish Vig, Founder & Director, (manish@world1solutions.in) at World 1 Solutions will coordinate official protocols pertaining to all the aforementioned areas of collaboration between Belarusian National Technical University and Sandip Foundation's, Sandip Institute of Engineering & Management.

## Article 2

1. The plans for cooperation in academic exchange, science and technology shall be implemented through:

1.1. exchange of experience in methodological and educational work; exchange of textbooks and training materials (training programs, educational methodological grants, etc.);

- 1.2. joint scientific research in various areas of science and technology;
- 1.3. exchange of scientific materials, publications and information, experience of scientific work and search of various forms of scientific cooperation;
- 1.4. exchange of students, graduate students and trainees along with the granting of the necessary conditions for their study and internship;
- 1.5. sending faculty members of the Parties to teach in order to assist in the training of personnel in the relevant specializations.

### **Article 3**

The Parties declare their readiness to provide support and assistance to the representatives (undergraduate students and staff) of the cooperating partner deputed for practical and academic training. All visits and assignment trips to the cooperating partner are to be arranged on approval of the receiving Party.

### **Article 4**

1. Each Party shall appoint an appropriate person to coordinate the cooperation activities and inform each other in writing about this person within 5 (five) working days from the date of the signing of this Agreement. The information letter includes: last name, first name and patronymic (if any) of the representative, telephone numbers and e-mail address. Through these contact persons, either Party may initiate proposals for activities under this Agreement.

2. The implementation of the articles of the Agreement on the territory of the Republic of Belarus and the Republic of India shall be carried out in accordance with the legislation of the relevant Party.

3. The Parties are obliged to respect the confidentiality of the terms of this Agreement and all information transmitted as confidential or as information which in nature should be considered confidential.

### **Article 5**

1. For separately concluded agreements, treaties under this Agreement, the Parties shall take all necessary actions aimed at their implementation.

2. This Agreement does not impose any financial obligations on the Parties. All financial issues arising in the implementation of this agreement will be regulated separately by bilateral treaties concluded.

### **Article 6**

1. This Agreement is made in 2 (two) copies in Russian and English. Both copies have the same legal force. For the purposes of the interpretation of the provisions of this Agreement, the text in English shall prevail.

2. The Agreement shall go into effect from the date of its signing by the Parties and be valid for 5(five) years from the date of signature.

3. All alterations and amendments to this Agreement shall be made upon the mutual consent of the two Parties. All written changes, additions and annexes to this Agreement shall be formalized by an additional agreement to this Agreement are its integral part and enter into force from the date of signing of the relevant additional agreement.

4. The Agreement can be terminated during its action according to the mutual agreement of the Parties expressed in writing form at any time. The Agreement will be considered terminated one month after the written notification of one of the parties of its cancellation by the other Party.

5. Disputes between the Parties related to the interpretation and (or) application of the provisions of this Agreement shall be resolved, first of all, through negotiations and consultations.
