SUMMARY: -

- 1) **The Unnat Bharat Abhiyan Scheme** is inspired by the vision of transformational change in rural development processes by leveraging knowledge institutions.
- 2) The conceptualization of Unnat Bharat Abhiyan started with the initiative of a group of dedicated faculty members of the Indian Institute of Technology (IIT) Delhi working for a longtime in the area of rural development and appropriate technology. The concept was nurtured through wide consultation with the representatives of a number of technical institutions, Rural Technology Action Group (RuTAG) coordinators, voluntary organizations, and government agencies, actively involved in rural development work, during a National workshop held at IIT Delhi in September 2014.
- 3) Dr. Puneet Jain is Coordinator at the college for the Unnat Bharat Abhiyan Scheme for Sandip Institute of Engineering and Management, Nashik. He is the only person going after it to approve the UBA Scheme and finally on 20th July, 2024 college is registered for this scheme.
- 4) Dr. Puneet Jain shared his knowledge of the Unnat Bharat Abhiyan scheme with Government School to aware of improving the quality of education of the students and life.
- 5) Dr. Puneet Jain shared his knowledge of the Unnat Bharat Abhiyan scheme with Gram Panchayat Sarpanch Mr. P. L. Shrikande and inform them about the scheme and give some innovative ideas to uplift lifestyle of the villagers.
